New Business:

a) Rezoning Request

A request has been made to rezone the property known as Plan 2605X, Block 6, Lots 28 – 35 from Commercial to Residential. Discussion.

b) Grant Application Approval

MPE has submitted the application for funding for the retrofit of the sewer lift station.

d) County Water Line

A complaint was made by a user of the water line directly west of Barons. Council will need to determine as to where does the Village go from here as the line was put in improperly and is a liability to the Village.

Motion made by Mayor Weistra to send letters to the users of this line that the Village is providing six months written notice as to the abandonment of this line unless the county ratepayers are willing to pay the necessary funds to bring this system into compliance.

e) Village Holiday Schedule

As in previous years, the Village Office and Public Works have been closed between Christmas and New Year's. It is proposed that the Office and Public Works be closed between noon on December 23rd to January 4th, 2022 inclusive.

Motion made by Deputy Mayor Doell to close the Village Office and Public Works at 12:00 noon on December 23rd and remain closed until January 4th, 2022. Carried

f) Wages/Christmas Bonuses

It is the recommendation to provide a cost-of-living increase of 4.7% for the Administrator and Public Works. It is also recommended that the Assistant Administrator be provided a wage increase to \$35,000 per year.

As in keeping with previous years, it is recommended that a Christmas bonus of \$500.00 for Administrator, Public Works Foreman and the Administrative Assistant.

Motion made by Mayor Weistra to approve a 4.7% cost of living increase for both the Public Works Foreman and Administrator.

Motion made by Deputy Mayor Doell to provide a wage increase to \$35,000 per annum for the Administrative Assistant.

Motion made by Mayor Weistra to provide a Christmas bonus of \$500.00 for Administrator Beck, Public Works Foreman Passmore and the Assistant Administrator Durell. Carried
